

## 2026 Mandarin Munchkins Colouring Contest (the “Contest”)

### Official Contest Rules

1. **CONTEST PERIOD:** Contest begins on Monday, March 9, 2026, at restaurant opening time and ends on Tuesday, March 31, 2026, at restaurant closing time (the “**Contest Period**”) and is subject to the terms and conditions set forth in these Official Contest Rules (“**Rules**”).
2. **ELIGIBILITY:** Contest is open to residents of Ontario who are at least eighteen (18) years of age (the “**Entrant**”) and who are the parent or legal guardian of a child twelve (12) years of age or younger (the “**Child**”), at the time of entry, except employees, representatives or agents (and those with whom such persons are domiciled, whether related or not) of Mandarin Restaurant Franchise Corporation (the “**Sponsor**”), its franchisees, its parent companies, subsidiaries, affiliates, prize suppliers and advertising/promotion agencies (collectively, the “**Contest Parties**”).
3. **HOW TO ENTER:** No purchase is necessary. Commencing on or about March 2, 2026, ask for an official Contest colouring sheet, while supplies last, at any of the 29 Mandarin Restaurant locations. The Contest colouring sheet will also be available to download and print from the Sponsor’s website page: <https://www.mandarinrestaurant.com/munchkin/>

For the Entrant to receive one (1) entry into the Contest, the Entrant’s Child must, by hand (using crayons, markers, pencils or paints (or a combination of these) and without the use of computer tools, A.I. or other electronic means), colour in the picture shown on the Contest colouring sheet and the Entrant’s full name, address, telephone number and e-mail address, as well as their Child’s first name and age, must be clearly hand-printed or typed, where indicated, on the colouring sheet. In order to be eligible to be entered in the Contest, the completed Contest colouring sheet must be signed by the Entrant and deposited in the designated Contest entry receptacle at a Mandarin restaurant location during the Contest Period. A completed Contest colouring sheet, together with the required information, is referred to in these Rules, individually, as a “**Entry**” or “**entry**” and, collectively, as “**Entries**” or “**entries**”. To be eligible for entry, the Entry must be the original, hand-completed Contest coloring sheet (with all required information) – not a photocopy, photograph or other reproduction of the original. The Sponsor and its franchisees will not be responsible for late, lost, illegible or incomplete entries.

**ENTRY LIMIT:** There is a limit of three (3) Entries per person and per family during the Contest Period. Without limiting the generality of the foregoing, but for greater certainty, each Entry must be a separately, originally fully hand-drawn Contest colouring sheet completed and signed in accordance with these Rules, and no more than three (3) completed Contest colouring sheets per individual Entrant or per family can be entered into the Contest. Entrants who submit more than three (3) Entries in the Contest may be disqualified, and all Entries submitted by such Entrant declared void, at the sole and absolute discretion of the Sponsor, and all Entries.

All Contest Entries are subject to verification at any time and for any reason. The Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor – including, without limitation, government issued photo identification): (i) for the purposes of verifying an individual’s eligibility to participate in this Contest; (ii) for the purposes of verifying the eligibility and/or legitimacy of an Entry entered (or purportedly entered) for the purposes of this Contest; and/or (iii) for any other reason the Sponsor deems necessary, in its sole and absolute discretion, for the purposes of administering this Contest in accordance with these Rules. Failure to provide such proof to the satisfaction of the Sponsor in a timely manner may result in disqualification, in the sole and absolute discretion of the Sponsor.

4. **PRIZES:** There will be twenty-nine (29) prizes (each, a “**Prize**” or “**prize**”) (one (1) per restaurant location) available to be won, each consisting of a voucher for a free buffet lunch or dinner for 4 at the Mandarin location where the confirmed Entrant was selected as a prize winner, and a Mandarin plush toy. Approximate retail value of each Prize is CDN \$185.00. The Prize must be accepted as awarded without substitution, is not transferable, not for resale and has no cash surrender value. The Sponsor

reserves the right to substitute another prize or prize component of equal or greater approximate retail value, without liability, including without limitation, but at the sole and absolute discretion of the Sponsor, a cash award.

All free meal vouchers must be used by no later than July 31, 2026. Blackout dates apply. Gratuities and beverages are not included.

Prizes will be awarded to the Entrant and must be picked up from the Mandarin restaurant location where the Entrant was selected as a prize winner. All prizes must be accepted as awarded. No transfer, assignment, cash redemption, or substitution of a prize (or portion thereof), except by Sponsor in its sole discretion. The Sponsor reserves the right at any time to substitute a prize for any reason so long as a prize of comparable value is substituted.

5. **DRAW:** Random draws will be held on April 1, 2026 at around 11:00 a.m. ET (the “**Draw Date**”) at all Mandarin restaurant locations from all eligible Entries received at the applicable location during the Contest Period, to select one (1) potential winner per restaurant location. The quality of the Child's drawing on the Contest colouring sheet will not be taken into account in the winner selection process. The odds of winning a Prize will depend on the total number of eligible Entries at the applicable location during the Contest Period in accordance with these Rules.
6. **WINNER NOTIFICATION:** The Entrant selected as the potential winner at each Mandarin restaurant location will be contacted by phone by a designated Mandarin restaurant representative of that location within five (5) business days following the Draw Date. If the potential winner does not respond to the designated representative contact person within three (3) days of the date of initial notification, then he/she may, in the sole and absolute discretion of the Sponsor or its designated representative, be disqualified (and, if disqualified, will forfeit all rights to the Prize) and the Sponsor reserves the right, in its sole and absolute discretion, to select an alternate potential winner selected from among the remaining eligible Entries received at the applicable location in accordance with these Rules.
7. By entering the Contest, the Entrant (in his/her own right and on behalf of his/her Child) expressly acknowledges and agrees that the Contest colouring sheet completed by the Child of the Entrant and entered in the Contest, and the first name and age of the Entrant's Child, may be reproduced and posted in the applicable restaurant or on the Sponsor's website, or via the Sponsor's social media accounts.
8. All entries will be submitted by the restaurants to the Sponsor and become the property of Sponsor, and no correspondence will be entered into except with selected Entrants, who will be notified by telephone. Entrants, by entering this contest, consent to the use of their name and/or photograph, without compensation, in any future publicity carried out by Sponsor in connection with this Contest and to the use of the completed Contest colouring sheet as provided in Rule 7.
9. Before being declared an official prize winner, the selected Entrant must first correctly answer a time-limited mathematical skill-testing question without assistance or mechanical or electronic aid and may be required to sign and return the Sponsor's form of declaration and release form within the timeline indicated by the Sponsor. By accepting a Prize, each winner: (i) confirms compliance with these Rules; (ii) acknowledges acceptance of the Prize as awarded; (iii) releases the Contest Parties, and each of their respective shareholders, directors, officers, employees and agents (collectively the “**Released Parties**”) from any and all liability in connection with this Contest, his/her (and his/her Child's) participation therein and/or the awarding and use/misuse of the Prize or any portion thereof; and (iv) agrees to the publication, reproduction and/or other use of his/her name, address, voice, statements about the Contest and/or photograph or other likeness, and of his/her Child's first name and age, without further notice or compensation, in any publicity or advertisement carried out by or on behalf of the Sponsor in any manner or medium whatsoever, including print, broadcast or the internet, including without limitation via websites or social media platforms.
10. If the selected Entrant: (a) fails to sign and return the declaration and release form within the timeline indicated by the Sponsor

(if applicable); (b) cannot accept (or is unwilling to accept) the Prize as awarded for any reason; and/or (c) is determined to be in violation of these Rules (all as determined by the Sponsor in its sole and absolute discretion); then he/she may, in the sole and absolute discretion of the Sponsor, be disqualified (and, if disqualified, will forfeit all rights to the prize) and the Sponsor reserves the right, in its sole and absolute discretion, to select an alternate potential winner from among the remaining eligible Entries received in accordance with these Rules. If the selected Entrant fails to correctly answer the skill-testing mathematical question, he/she will forfeit all rights to the Prize and the Sponsor reserves the right, in its sole and absolute discretion, to select an alternate potential winner from among the remaining eligible Entries received at the applicable location in accordance with these Rules. (For the avoidance, such alternate potential winner must also correctly answer a skill-testing mathematical question in order to be declared the prize winner.)

11. **GENERAL:** The Released Parties do not assume any responsibility for (i) the incorrect or inaccurate capture of entry information and entries that fail to comply with these Rules; (ii) any loss, damage, or claims caused by an awarded prize or the Contest itself; or (iii) any failure of any app or website during the Contest Period, including any problems, human or technical, printing errors, lost, delayed, garbled data or transmissions, omissions, interruptions, deletions, defects or failures of any telephone or computer lines, or technical malfunction of any computer on-line systems, servers, access providers, computer equipment, software, failure of any e-mail, Entry, direct message, to be received on account of technical problems or traffic congestion on the Internet or at any website, or any combination thereof including any injury or damage to an entrant's or any other person's computer or mobile device related to or resulting from downloading any material connected to the Contest, all of which may affect a person's ability to participate in the Contest. Entry material/data that has been tampered with or altered is void.

By entering the Contest and submitting, or purporting to submit, an entry, each Entrant (or purported entrant): (i) agrees to be bound by these Rules and by any and all decisions of the Sponsor with respect to this Contest, which are final and binding on all Entrants (or purported entrants) without right of appeal; and (ii) agrees to release and hold harmless the Contest Parties and each of the Released Parties from and against any and all claims arising out of, or with respect to, the entrant's (or purported entrant's) participation in this Contest and the awarding, use or misuse of any prize.

The Released Parties will not be liable for the failure of any Entry to be received as required by these Rules within the Contest Period for any reason whatsoever, including, but not limited to: (i) restaurant closures for any reason; (ii) damages, delays or closures of, in, or to, any roadways, transportation systems; and/or (iii) any combination of the above.

In the event of a dispute concerning who submitted an Entry, in whole or in part, the Sponsor reserves the right to require, from each person claiming to have submitted such Entry, such evidence as the Sponsor may, in its sole and absolute discretion, require in order to enable it, or any person designated by the Sponsor, to resolve such dispute to the Sponsor's satisfaction. If a dispute regarding who submitted an Entry cannot be resolved to Sponsor's satisfaction, the applicable Entry may, in the Sponsor's sole and absolute discretion, be deemed ineligible.

The Sponsor reserves the right, in its sole and absolute discretion, and without prior notice, to adjust any of the dates and/or timeframes stipulated in these Rules, to the extent necessary, for purposes of verifying compliance by any entrant or Entry with these Rules, or as a result of any technical or other problems, or in light of any other circumstances which, in the opinion of the Sponsor, in its sole and absolute discretion, affect the proper administration of the Contest as contemplated in these Rules, or for any other reason.

All issues and questions concerning the construction, validity, interpretation, and enforceability of these Rules, or the rights and obligations of Entrants (or purported entrants) and the Sponsor in connection with the Contest, shall be governed by, and construed in accordance with the laws of the Province of Ontario and the laws of Canada applicable therein, without regard to conflicts of law principles.

In the event of any discrepancy or inconsistency between the terms and conditions of these Rules and disclosures or other statements contained in any Contest related materials, including, but not limited to point of sale, print or online advertising, the terms and conditions of these Rules shall prevail, govern and control to the fullest extent permitted by law.

The Sponsor reserves the right to withdraw, amend or suspend this Contest (or to amend these Rules) in any way, in the event of an error, technical problem, computer virus, bugs, tampering, unauthorized intervention, fraud, technical failure or any other cause beyond the reasonable control of the Sponsor that interferes with the proper conduct of this Contest as contemplated by these Rules. The Sponsor reserves the right to cancel, amend or suspend this Contest, or to amend these Rules, in any way without prior notice or obligation, in the event of any accident, printing, administrative, or other error of any kind, or for any other reason whatsoever. Any attempt to deliberately damage any website or to undermine the legitimate operation of this Contest is a violation of criminal and civil laws and, should such an attempt be made, the Sponsor reserves the right to seek remedies and damages to the fullest extent permitted by law.

12. **PRIVACY POLICY:** By entering this Contest, each entrant expressly consents to the Sponsor, participating Mandarin restaurant locations and their respective agents and/or representatives, storing, sharing and using the personal information submitted with his/her Entry only for the purpose of administering the Contest and awarding the Prize if applicable. This Rule 12 does not limit any other consent(s) that an individual may provide the Sponsor, any Mandarin restaurant or others in relation to the collection, use and/or disclosure of their personal information.
